- -Chesapeake Appalachia, LLC- PA Woodlands Drilling Pad located in Elkland Township off North Street. Notices that they are applying for an Erosion & Sediment Control General Permit (ESCGP-3) associated with oil and gas exploration, production, processing or treatment operations or transmissions facilities.
- -Chesapeake Appalachia, LLC- PA Loyalsock Creek Surface Water Withdrawal Application located in Forksville Borough. Filed Notice with the Susquehanna River Basin Commission (SRBC) for a notice of intent (NOI), the consumptive use to withdraw up to 1,500,000 gallons per day from the Loyalsock Creek.
- -Lobaugh, Todd NPDES application for a stormwater management facility for a proposed 2,644 square foot residential single-family home with a 1,200 square foot garage.
